



## **ONE-DAY ACHASM GAUTENG 2018 CONSTRUCTION HEALTH AND SAFETY (H&S) SYMPOSIUM, BYTES CONFERENCE CENTRE, HALFWAY GARDENS, MIDRAND, 12 MARCH 2018**

### **SYMPOSIUM FOCUS**

The summit will focus on modern technology in the form of building information modelling (BIM) and its role in H&S, and topical issues such as client baseline risk assessments (BRAs), cost of accidents, H&S culture, medical surveillance, motor vehicle accidents (MVAs) during construction, SMEs / subcontractors and H&S, support work and formwork, and the role of procurement in H&S. Furthermore, the Construction Industry Development Board (cidb), Department of Labour, and the South African Council for the Project and Construction Management Professions (SACPCMP) will provide an update relative to their industry H&S related mandate. The focus is attributable to media coverage afforded the construction industry in terms of 'accidents', and collapses, in addition to the incidence of fatalities, notwithstanding the fact that 'one fatality is one too many'.

### **OBJECTIVES**

Upon the 11th anniversary of the Association of Construction Health & Safety Management (ACHASM), the one-day ACHASM Gauteng 2018 Construction Health and Safety (H&S) Symposium will provide a forum for construction industry stakeholders to address construction H&S related matters. The symposium will be commercial in nature and aims to stimulate interaction between all the stakeholders active in the industry.

#### **The broad objectives of the summit are to:**

- Educate and inform all stakeholders with respect to construction H&S compliance, and better practice;
- Promote the practice of construction H&S risk management;
- Promote accountability, awareness, competency, ethics, professionalism, and leadership, in managing and implementing construction H&S;
- Develop understanding and appreciation of the role of procurement, and supply chain management (SCM) in managing construction H&S;
- Develop understanding and appreciation of temporary works design focusing on support work, and
- Provide a platform for exchanging ideas and networking with likeminded professionals.
